The Club may suspend or terminate membership rights upon notice and an opportunity for a hearing before the Board of Directors, if the account is delinquent for 30 days or more, or for violation of the Club's Governing Documents. Suspensions shall remain in effect until the balance of the account owing for the entire membership year is paid, or for violations of the Governing Documents for a period of time to be determined by the Board of Directors or its designee as										

determined at the time of the suspension. Neither suspension, termination nor non-use of the facilities shall discharge or offset the obligation to pay dues, fees, or charges. In addition to suspension or termination of membership for violations of the Governing Documents, the cost of all damages will be charged to the Club Member.

Members violating the Governing Documents will result in the following actions: First infraction, written warning notice, except for Code of Conduct violations. Second Infraction and Code of Conduct violations, written notice and disciplinary hearing before the Board of Directors or the Board Hearing Panel which may include a fine and membership suspension.

The Member is responsible for any attorney's fees and costs incurred by the Club in connection with the collection of dues, fees and charges. In the event a dispute arises over the interpretation or enforcement of the Agreement, the prevailing party shall be entitled to attorney's fees.

The Club reserves the right to refuse, or to not renew any membership. All membership applications are subject to review by the Board of Directors or its designated representatives. This membership is valid only for the persons designated on this membership application. Any charges incurred by authorized account signatories or by guests of the designated Club Members are the responsibility of the Member. By signing this form, the Club Member authorizes the Club to charge the Club Member's credit card for any and all charges incurred by the Club Member, the Club Member's authorized account signatories, or by the Club Member's guests when said charges are more than sixty (60) days past due including any late fees and interest.
